Consents and permits

For constructions and alterations in a main river, an environmental permit may be required from the Environment Agency. Information about environmental permitting is available on the .gov.uk website: https://www.gov.uk/topic/environmental-management/environmental-permits.

For works within an Internal Drainage Board district, consent may be required from the board. You can find out whether an area is within an Internal Drainage Board district using the ADA IDB map. Click on the district area to find the contact details for the board: https://www.ada.org.uk/idb-map/ If the works are on an ordinary watercourse that is not within an Internal Drainage Board district, consent may be required from Cambridgeshire County Council. This is a charged service (£50 per structure) and can be applied for on our website - see link below. Litter and Fly Tipping

It is not uncommon for flooding and drainage issues to arise from excessive littering and fly tipping or illegal waste dumping. This can also attract pests and there are additional impacts on water quality, biodiversity and of course the amenity benefits of living near water may reduce.

Dumping of vegetation, such as hedge trimmings or grass clippings is classified as illegal waste dumping. Vegetation can obstruct the light in a watercourse, and strips the water of oxygen, which is damaging for any resident fish and other wildlife.

It is much safer for yourself and the environment, to dispose of waste in the following ways:

- Composting organic waste for re-use on your garden or land.
- Community litter picks
- Local Authority bin collection
- At your local waste recycling centre
- Via your local bulky waste collection service (either by your local authority or private)

Lower tier authorities are responsible for bin and waste collection. In Cambridgeshire these are district councils¹. You can report littering or fly tipping incidents to them, and at some authorities you can request a new community litter bin, a street clean, or the collection of bulky waste.

My Cambridgeshire

You can find out lots of useful information, such as what the lower tier authority is for your area, using "My Cambridgeshire" online mapping available at: https://my.cambridgeshire.gov.uk/

To find your lower tier authority, open the "Council and Democracy" Category and check the "Districts" layer, then search for the address concerned and click the map over the location of the address.





Geology

It is important to know the ground conditions you will be working with before starting maintenance or other works to a watercourse or water body. British Geological Survey have a free online mapping software called GeoIndex, which is available to view at: https://mapapps2.bgs.ac.uk/geoindex/home.html.

The main data sets of concern are Superficial Deposits (which are the top layer of geology) and Bedrock (which are the lower layer). Not all locations have superficial deposits, but everywhere has bedrock. To view this data, click "Add data" and then click the green plus sign for "Bedrock Geology 1:50,000" and "Superficial Deposits 1:50,000". Then zoom to your desired location. The data is only visible up to a scale of 1:50,000m, however this is usually sufficient for local level works.





Highway and Public Right of Way Implications

If a road or pavement is likely to be impacted by any maintenance works then permission should be sought from Cambridgeshire Highways via a temporary traffic regulation order, so that appropriate signage and diversions may be arranged.



Utilities Searches

If undertaking particularly intrusive works that penetrate below the ground surface or are likely to affect any pipe bridges, we recommend you carry out utilities searches advice and guidance on easements.
