1	Welcome and apologies for absence	
1.1	JE welcomed everyone to the meeting and introduced Phil Stevens as Ely Diocese representative (committee B).	
1.2	Apologies had been received from Reverend Robert, Shirley Hall, Philippa Slatter and Dennis Johnson.

2.1	The minutes were agreed as a true record.	
2.2	Matters arising -Obtaining information and documents from secondary schools – AF explained that as all Cambs secondary schools are now academies, be mindful that they are not obliged to provide any information. We are able to send a polite request however this would be done through Schools News and not directly - for further discussion. Determination and the change from Christianity to multifaith – who has the responsibity to ensure Christianity is taught? Is there a balance to ensure that Christianity doesn't disappear? AF explained that whilst Ofsted rarely look at collective worship or comments on it, they will go into an assembly and this is a good indicator. There is a chance that AF may be able to support with this matter as part of her role with school improvement – for further discussion.	
3.0	SACRE Membership / Recruitment strategy	
3.1	JE advised that the vacancies are predominantly in committee A. The clerk had again made contact with the Buddhist centre and the Orthodox / Methodist church. JE invited members views on whether to retain the 3 representatives. JE raised the important matter of being constitutionally quorate within each committee and of ensuring there is the correct representation of faith groups.	
	A discussion followed about the remit of committee A. The clerk referred members to the constitution and terms of reference which is in the appropriate sub folder Teams. The chair said it would be helpful if members familiarised themselves with these documents prior to attending their first meeting, once issued by the clerk	
4.0	Correspondence and updates – NASACRE / DfE etc	
4.1	The clerk had circulated the following documents to all members: NASACRE insights report NASACRE document - Reviewing the RE Curriculum in the light of a National Statement of Entitlement and Big Ideas for RE.	

The clerk advised that she had circulated guidance to all members from NASACRE following the recent cyber security attack and associated phishing emails. The clerk advised members not to respond to out of the ordinary emails from her.

5.0 Short report on the new SACRE and RE system adopted by the Welsh government

JE advised that the <u>The Curriculum and Assessment (Wales) Act</u> received royal assent in April 2021 and will come into force from September 2022. It sets new curriculum requirements for all learners aged 3 to 16 in maintained or funded non-maintained including nursery education.

The new curriculum is designed to include more emphasis on skills and experiences as well as knowledge. The curriculum groups education into six "Areas of Learning and Experience" with the intention of helping teachers draw links between subjects and teach topics in a broad way although traditional subjects will still be taught. The area are Expressive Arts, Health and wellbeing, Humanities, Science and technology, Maths and Numeracy, Languages, Literacy and Communication. Within a basic framework of goals and learning areas, it give schools freedom to develop their own curriculum to suit the needs of their pupils. Other changes include a greater emphasis on the history of Wales and ethnic minority groups.

The four purposes should be the starting point and aspiration for schools' curriculum design. Ultimately, the aim of a school's curriculum is to support its learners to become:

- ambitious, capable learners, ready to learn throughout their lives
- enterprising, creative contributors, ready to play a full part in life and work
- ethical, informed citizens of Wales and the world
- healthy, confident individuals, ready to lead fulfilling lives as valued members of society

The name of the subject of 'religious education' (RE) will be changed to 'religion, values, and ethics' (RVE), to reflect this broader scope.

The Act has not gone as far as imposing a national syllabus for RVE. It remains a locally written in the 22 local authority areas.

The Act means that, in line with the Human Rights Act 1998, humanism will be taught on an equal footing with religions in the school curriculum and clarifies that humanists may sit on the bodies that oversee and develop the syllabus.

In addition to the changes to RE, the Act will introduce an array of other sweeping reforms. These include objective age-appropriate relationships and sexuality education (RSE) for all pupils aged 3-16, with no parental right to withdraw.

Schools will also have a legal duty to promote knowledge and understanding of the UN Convention on the Rights of the Child.

Parents whose children attend voluntary aided faith schools will also be given the right to have them taught objective RVE lessons in line with the inclusive syllabus taught in other schools, rather than faith-based lessons.

From September there will be no parental right to request withdrawal from religion, values and ethics (RVE) in respect of all learners up to and including year 6. From September 2023 there will be no right to withdraw for years 7 and 8 learners.

Is it the Welsh initiative who drives this? There is a national curriculum, but the schools have more flexibility than formally. Writing an agreed syllabus for RE lies with the SACRES.

AF mentioned that in the white paper it was suggested that SACRE consider strategically how they adapt to the white paper and ensure they can effectively monitor provision. We have established that there is lack of guidance for academies. A member said that there is generally a lack of terminology with regards to faith-based academies. There is a difference between this and faith schools. AF said to be aware that LAs such as Cambs do have a large number of community schools and will be able to set up their own academy trusts so SACRE should watch carefully how CCC choose to respond to the white paper. At present there is still a requirement to have an agreed syllabus but the standard of RE being taught is not consistently good.
